REGISTRAR'S CIRCULAR NO 5 OF 1999

WEEKLY LAW NOTICE AND OTHER COURT OF APPEAL AND HIGH COURT FIXTURES LISTS.

To promote the use of IT and as an additional service to counsel and other court users, the above lists have been made available at no charge on the Supreme Court's website at http://www.supcourt.gov.sg since 1996. To enhance its usefulness, additional fields of information have been captured and included in the above from time to time including the names of counsel and the law firms representing the parties. This information has, hitherto, been gleaned by Registry officials from a perusal of the most current court documents in each file.

- It has been brought to the attention of the Honourable the Chief Justice that there have been some cases where counsel appearing for the parties at the hearing proper has differed from that listed in the court papers, and hence the law notice and other fixtures lists were inaccurate.
- To assist the Registry to prepare more updated and accurate law notices and other fixtures lists reflecting the names of counsel appearing at the hearings proper, the Honourable the Chief Justice has directed that counsel for parties appearing in all hearings before the Court of Appeal and trials or hearings before the Judges and Judicial Commissioners of the High Court shall, with effect from 1 January 2000, submit the attached response form at least 14 days before the date listed for the trials or hearings before the Court of Appeal or High Court. Any changes after the submission of the response form should be immediately notified to the Registry using a fresh copy of the notification form marked amended or re-amended notification, as the case may be.
- For the avoidance of doubt, this circular shall apply to criminal cases before the High Court and the Court of Appeal. It does not, however, apply to hearings before the registrars of the Supreme Court.
